- 'Botanicals' is the commonly used descriptor for herbals marketed under food law
- 'Quality' is synonymous with high standards and excellence
- Botanicals are the fastest growing class of ingredients globally, estimated to be worth \$35 billion by 2020
- The European market for botanical food supplements is estimated to be worth €2.1 billion annually
- The quality of botanical products has recently been seriously questioned in the media, primarily in the US but now also here in the UK. These challenges to product quality are both serious and ongoing, and UK industry needs to ensure that its house is in order
- This seminar will aim to do just that. Led by technical experts from industry and academia, the presenters will examine the building blocks of quality management and how best to ensure excellence throughout the supply chain, from raw material, through manufacturing, to finished product
- This seminar will prove invaluable not just for those with a technical background, but also anyone that is involved in, and concerned about, the marketing of safe and efficacious botanical products
- Ample time will be allowed for questions and discussion
